RELEASE/WAIVER OF LEGAL RIGHTS

All riders must sign a waiver of claim below to participate in the Southwest Tandem Rally.

I ACKNOWLEDGE THAT BY SIGNING THIS DOCUMENT, I AM RELEASING THE DOUBLE DATES, ITS MEMBERS, OFFICERS, AND AGENTS FROM LIABILITY. THIS RELEASE IS A CONTRACT WITH LEGAL CONSEQUENCES, AND I HAVE READ IT CAREFULLY BEFORE SIGNING.

I acknowledge that cycling is an inherently dangerous sport and fully realize the dangers of participating in group rides. I FULLY ASSUME THE RISKS ASSOCIATED WITH SUCH PARTICIPATION.

For myself, my heirs, executors, administrators, legal representatives, assignees, and successors in interest (collectively "Successors"), I HEREBY WAIVE, RELEASE, DISCHARGE, HOLD HARMLESS, PROMISE NOT TO SUE, AND INDEMNIFY the Double DATES, its members, ride leaders or hosts and officers (collectively the "Released Parties") from any and all rights and claims including claims arising from the released parties' own negligence, gross negligence or intentional conduct, which I have or which may hereafter accrue to me, and from any and all damages which may be sustained by me directly or indirectly in connection with, or arising out of, my participation in or association with an event sponsored by Double DATES.

I understand and agree that situations may arise during a ride which may be beyond the immediate control of the leader(s) or host(s), and I must continually ride so as to endanger neither myself nor others. I accept responsibility for the condition and adequacy of my own bicycle equipment. I will wear a helmet that satisfies the requirements of the ANSI Snell regulations that can protect against serious head injury, and I assume all responsibility and liability for the selection of such a helmet. I have no physical or medical condition which to my knowledge would endanger myself or others if I participate in Double DATES rides or would interfere with my ability to participate in such rides. I agree that should I or my successors assert my claim in contravention of this agreement, the asserting party shall be liable for the expenses (including legal fees) incurred by the other party or parties in defending.
